The 1924 and 1952 act bothe heavily favor Western European immigrants. Not only did it do that, but it added a new section aswell. Section 212(f), states: "Whenever the President finds that the entry of any aliens or of any class of aliens into the United States would be detrimental to the interests of the United States, he may by proclamation, and for such period as he shall deem necessary, suspend the entry of all aliens or any class of aliens as immigrants or nonimmigrants, or impose on the entry of aliens any restrictions he may deem to be appropriate." This gave the

President the ability to try to overrule those quotas. This article also talks about how one of the biggest critics for this act was President Truman. He said that the law is "a slap at millions of Americans whose fathers were of alien birth". He also denounced it for "substituting totalitarian vengeance for democratic justice." He says that we should have a helping hand to those who are living under communism and worry less about trying to protect the US from it. Unfortunately, Congress overruled this veto.
